



**Estimated Tuition and Fee Schedule for
FGS University Consortium 2+2 Students
(Fo Guang University and Nanhua University)**

- 2+2 tuition arrangements – FY2024-2025
 - 40% tuition discount per semester, US dollars.
 - The tuition waiver covers a maximum of 12 units per semester for a maximum of four semesters (fall and spring).
 - \$1,500 subsidy from donors, per student, per semester.
 - BLIA provides \$500 on-campus housing fee subsidy, per student, per semester.

2+2 students are required to purchase the basic package for Room and Board. **We currently do not offer meal plans.** Students will need to pay an associated \$50 housing application fee, a \$200 security deposit, and a \$20 mailbox fee. The security deposit is fully refundable when the room is returned in good condition.

International students are required to enroll in at least 12 units per semester (four 3-unit courses) and are required to purchase student health insurance **here in the US**. Currently, health insurance costs \$139 per month. (This amount may increase as it is regulated by a health insurance company. UWest cannot control the cost of health insurance.)



Finally, the student's book and class materials, food, other materials, airport pickup, incidental expenses, and travel costs are not included in the costs listed above and are the responsibility of the individual student.

+++ The tuition discount covers a maximum of four 3-unit courses (12 units/semester) for four semesters (fall and spring). The student is responsible for any tuition associated with units and courses beyond this limit (12 units/semester) and payment for these units at the standard UWest tuition rate should be remitted directly to UWest. Students are also responsible for tuition for course(s) during the summer term and for any units incurred beyond the overall 48 units allowed. (The student should be aware that they may be required to take courses beyond these limits in order to complete their degree, and it is the student's responsibility to pay for these additional units/courses at the UWest tuition rate directly to UWest.)

* All rates and fees are subject to change upon advance wrote notice.

* In order for the Form I-20 to be issued, please provide at least \$15,000 USD bank statement. This amount is an estimate based on typical average costs. Actual costs may be higher or somewhat lower depending on a student's particular circumstances. This is the minimum amount needed for the bank statement for the I-20. However, U.S. counselor officials may view your bank statement with higher amounts more favorable.
