- 4.學生於申請學位考試前，需至「臺灣學術倫理教育資源中心」線上平台自行修習「學術倫理教育」課程，並通過課程總測驗及成績達及格標準。

Course Description:

1. Elective courses: including investment analysis course group and risk management course group, at least five elective courses for investment analysis course group, and at least four elective courses for risk management course group.
2. A maximum of 15 credits per semester for in-service students. The maximum credits per semester for in-service students is 12 credits. Those in-service students who have not studied “Economics”, “Accounting”, “Statistics”, and “Financial Management” courses in college must first take the identification test. If those in-service students fail to pass, it is necessary to take relevant courses in the college.
3. Informal courses: Before graduation, one or more papers must be accepted at an academic seminar with a review system, and then an oral examination can be applied; career counseling two times; one dissertation, (two corporate visits or off-campus internships), and one professional certificate are considered to meet the graduation requirements.
4. Before applying for degree examination, students need to take the academic ethics education course on the Center for Taiwan Academic Research Ethics Education online platform. In addition, they need to pass the final exam and get a passing grade.
